

Society of Nirmala Dasi Sisters is a religious community, which is founded by Rt. Rev. Dr. Joseph Kundukulam (late) first Archbishop of Thrissur, Kerala State, India, in 1971. The motto of this Society is "Yes Lord, Here I am." Considering the need of the people of the locality the Society is started to serve the needy with an open hand without any restriction other than a deserving human being! We have at present 48 communities and 265 professed sisters spread out in different states of India, and abroad, including the desert of Kenya (Africa), and in a village of Hungary.

The prime concern of our Mission is to serve Christ in the most abandoned section of the society, poor, the sick and the destitute without any remuneration. Our services are rendered in various sectors in different places like the care of unwed poor mothers, destitute babies, lepers, mentally challenged persons, HIV/AIDS patients, disabled and old people, terminally ill & bedridden patients, mentally ill people, slum dwellers and Victims of drug addiction. The needs of their body, mind and spirit are equally considered important and as far as we can, we avail them.

Description of the project

In the year 1983 the Society of Nirmala Dasi Sisters have extended our service at East Africa especially in Wamba, Kenya, Korr, Ngaramara, Sagana, Marsabit etc (totally remote and desert areas), for the down trodden and the neglected from the society under different Dioceses of Africa.

We sisters came to Ngaremara in 1993. We are working in the parish in different activities. One sister is in-charge of dispensary. Besides that outside mobile clinics and food distribution for below five malnutrition children. One Sr is in-charge of nursery schools, primary schools and sponsorship project. One Sr is doing pastoral work. One Sr is in charge of hostel boys and girls primary school. It can accommodate 70 children. One Sr is in-charge of MANYATTA ALAKARA A SMALL HOME FOR THE PHYSICALLY CHALLENGED CHILDREN. At present there are 40 children girls and boys below 18 who are going to nursery school up to class eight.

Among these 40, there are ten children who are physically and mentally challenged not able to cope well with others. Even the school is not accepting them also there is no accommodation facilities in Alakara home. Yet it is evident that some of such children have been neglected and languishing at home to this effect then our aim impels us to care for such children and give them our love and service so as to make them feel wanted at home.

I am glad to inform you that our society has decided to start a home for the mentally challenged children with an accommodation of 30 children, which is a need of the particular area at Ngaremara in the Vicariate of Isiolo Kenya.

It is a really a great need of the place Ngaremara Isiolo district Kenya to have a home for the mentally challenged children. Many are rejected from their family and beloved ones and seeking a place to make their future life happy and useful for them and for the community.

For this purpose we requested to the county council. They granted us 15 acres of land from the Isiolo county council. But to construct a building is beyond our financial status at present. If the project is fully completed, we will be able to accommodate 30 children both boys and girls. We rely on good-minded people and well-wishers.

Justification of the project

‘Providence home’ is meant for mentally physically children within the area and neighboring area. Our main object is to create an enabling environment in which each and every child can fulfill their potentialities; Protect, respect, promote and fulfill the rights of the children with disabilities. They also need strengthening at all levels. The home also serves along side the poor and oppressed regardless of the person. Most of the children are really a burden for their families as well as the society. The children are neglected and abandoned at home also in the society even public places. They believe that disability is a curse.

It is for this purpose that we are humbly requesting your help with the above mentioned home with the sole purpose of establishing a home for boys and girls mentally retarded. So they need a special cares (like daily living activities washing, eating, dressing themselves and environmental activities) where they can be taught in the special school. In this area there is no special school for these children. This is the heartbreaking situation which makes them feel that they are thrown out.

In this situation it is very important to have a home for them. The same time to have a special school for their daily scholastic improvement. Since many of them are physically challenged they need daily physiotherapy in order to prevent more contracture of muscles. To do the physiotherapy it is needed to have a hall for this purpose. These children’s IQ level is not coping with the normal children. In order to help these children we need special school and special educated teachers. Most of them are not able to study. In order to discover their ability we have to rehabilitate them.

FENCING

We would like to give some information about the area where we are going to start the home. Providence Home is 25 km away from Isiolo town on the way to Moyale. The area itself is called NGAREMARA. This area is semi arid desert. It is one k.m. inside from the main road. It is also 3 k.m. away from SAMBRU, SERENA Park. Usually the animals will move at any time from the park. They can also move through this area where we are going to start the home and special school. Since we got the land we did the local fencing with thorn tree (like Accasia tree) but it was destroyed by the animals and strong wind. But if there is a strong fence so that animals can move in a different direction. According to the situation of the area it is necessary and important to be fenced before starting any activities for the children. Estimated quotation is
